**SECURITY ASSISTANT GRADE-II (TECHNICAL)** - No candidate has qualified for appearing in the Personal Interview.

2. The Personal Interview will be held in Parliament Complex as per the following schedule:

28.05.2011 (Saturday) - Roll Nos. 100019 to 106444  
29.05.2011 (Sunday) - Roll Nos. 106732 to 400360

3. The cut-off percentage of marks in the Written Test (in each paper and aggregate) is 50% for UR vacancies, 45% for OBC vacancies and 40% for SC/ST vacancies.

4. In the call letter issued to the candidates, it was mentioned that the answer sheets of the Written Test of only those candidates who qualify all the events of Field Tests would be got evaluated. Accordingly, the answer sheets of only 271 candidates for the paper on 'General Studies'; 265 candidates for the paper on 'English Essay, Precis and Grammar'; and 25 candidates for the paper on 'Mathematics and Science' who qualified the vision tests have been got evaluated. 5. The candidates should bring the following documents/testimonials at the time of Personal Interview:

- (i) Original certificate of Matriculation or equivalent examination as proof of date of birth.
- (ii) All original certificates of Educational and other qualifications.
- (iii) All original certificates of NCC/Sports.
- (iv) Original certificate of hill area resident, if any, issued by the competent authority.
- (v) Original Caste Certificate issued by the competent authority (in case of SC, ST and OBC candidates).

6. In case, a candidate has done a computer course, he/she should bring the original certificate thereof at the time of Personal Interview. However, the credit for the same shall be given only if it is accompanied by a declaration by the concerned institute that the computer course done by the candidate is recognized by the All India Council for Technical Education (AICTE)/Department of Electronics Accreditation of Computer Courses (DOEACC) or the course is equivalent to 'O' Level in terms of syllabus and duration of course as prescribed by DOEACC.

7. The minimum cut-off percentages of marks in Personal Interview is 50%, 45% and 40% for vacancies in GENERAL, OBC and SC/ST categories, respectively.

8. Selection will be made on the basis of overall performance of the candidates in the Descriptive Type Written Papers and the Personal Interview, subject to the availability of vacancies.

9. The decision of the Joint Recruitment Cell regarding allocation of Lok Sabha Secretariat or Rajya Sabha Secretariat to the successful candidates shall be final.

10. The attention of candidates is drawn to the following declaration made by them in their applications to the above said post:

*"I declare that I fulfil the eligibility conditions as per the advertisement and that all the statements made in this application are true, complete and correct to the best of my knowledge and belief. I understand that in the event of any information being found false or incorrect at any stage or not satisfying the eligibility conditions according to the requirements mentioned in the advertisement, my candidature/appointment is liable to be cancelled/terminated."*
